COURSE PURPOSE

To provide students with a comprehensive understanding of the intersection between governance, politics, and socio-economic development from secular and Christian perspectives. The course will explore the impact of local and global politics on nation-building, critically examine various political ideologies, and highlight God's plan for making a nation prosperous through just governance and ethical leadership.

3. Identify and analyze the impact of national and global politics on socio-economic development.
4. Discuss various political ideologies and their influence on development, with a focus on Judeo-Christian traditions.

5. Make informed choices and decisions in development planning, considering ethical principles and political trends.
